- 1.2 Cooperation of the First Party and Second Party will facilitate effective utilization of the intellectual capabilities.


**CLAUSE 2: SCOPE OF THE MoU**


**2.1 PURPOSE**

- i. To build a technical relationship between the two bodies.
- ii. To work in collaborative mode for identification of technology and knowledge gap of the faculties and the students, and bring a solution by way of organizing
  - (a) seminars
  - (b) workshops
  - (c) brainstorming sessions
  - (d) faculty development programs
  - (e) add-on courses
  - (f) skill-development programs
  - (g) research and development (R&D) in theatre

**2.2 COMMITMENTS**

- i. **Palem Panthou Cultural Trust, Langjing Achouba, Imphal** and **Nambol L. Sanoi College, Nambol** will conduct joint events like workshop, seminar, and training program.
- ii. **Palem Panthou Cultural Trust, Langjing Achouba, Imphal** shall intimate **Nambol L. Sanoi College, Nambol** regarding the availability of training programs for students and faculties (e.g., Short Term, Long Term, Internship Training, Summer Training, projects, Faculty Development programs etc.).
- iii. **Palem Panthou Cultural Trust, Langjing Achouba, Imphal** and **Nambol L. Sanoi College, Nambol** will share infrastructure and manpower whenever required.
- iv. **Palem Panthou Cultural Trust, Langjing Achouba, Imphal** and **Nambol L. Sanoi College, Nambol** shall collaborate to facilitate the placement of successful candidates on completion of the training.

- 3.1 There will be no **financial obligations on both parties under this agreement.**

### CLAUSE 4: VALIDITY AND AMENDMENT

- 4.1 The validity of this MoU would be for a period of two (2) years with effect from the date of signing of this MoU. The MoU may be renewed on mutually agreed terms between the Parties.
- 4.2 Either party may terminate this MoU by giving six (6) months advance notice in writing to the other party.
- 4.3 The provisions of this MoU may be amended at any time with the mutual consent of the Parties in writing.
- 4.4 The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination, and expiration unless otherwise agreed upon between the parties.

### CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

- 5.1 This MOU shall be consumed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be construed to create any legal relationship between the Parties. Details of specific cooperation will be determined on a case-by-case basis and by mutual agreement consistent with this MoU.






